1. The tenders should be addressed to the officer mentioned below in a sealed cover with the tender number and name of the material duly super scribed on the cover.
2. The tenders should be in the prescribed form which can be obtained from the Head Office, Kottayam on payment of Rs. 600/- + 12 % GST VAT on all working days from 16.02.2019 to 25.02.2019 till 1 PM. Tender form can also be downloaded from our website and can submit along with the cost of tender form, Rs 600/- + 12% GST (In addition to EMD Rs 3000/- ) In the form of **DD favoring 'Kerala Forest Development Corporation Ltd ' payable at Kottayam.** The cost of tender forms once paid will not be refunded. Tenders will be accepted only up to 2 P.M. on 25.02.2019 . Tenders which are not in prescribed form and not accompanied by EMD of Rs 3000/- (Rupees Three thousand only) and without samples will be rejected.
3. The tenders will be opened at 3 P.M. on 25.02.2019, in the presence of those tenderers or their nominees who may be present at that time.

4. If any tenderer withdraws his tender, the earnest money if any, deposited by him will be forfeited to the Corporation or such action taken against him as the Corporation deem fit.
5. All pages of the tender document should be signed by the Tenderer in acceptance of the terms and conditions.
6. Tenderer shall supply the articles within 15 days of acceptance of the tender at the places specified below.

11. Unapproved samples should be got back by the tenderers at their own cost. The approved samples may or may not be returned at the discretion of the Corporation. The Corporation will not be responsible for any sample if found missing at any time due to the non-observance of the provisions of this clause.
